Committee Meetings

Committee Charge

- Maintain compliance with federal law related to the Children's Internet Protection Act (CIPA)
- Maintain compliance with Board policy
- Maintain governance over the district's electronic communication and data management (CQ-R) Administrative
 Guideline for Internet Content Management and Filtering
- Provide input from your role's perspective
- Provide feedback on the district's Internet content management and filtering practices
- · Consider requests from employees to use or unblock a blocked site
- Make recommendations regarding approval or disapproval of disabling the filter

Committee Meetings

- The committee will hold a minimum of two meetings a year. A
 majority of committee members should be present to hold any
 scheduled meeting.
- Failure to attend two consecutive meetings will result in removal from the committee.

Federal law - Children's Internet Protection Act (CIPA)

- Children's Internet Protection Act (CIPA) enacted by Congress in 2000 to address concerns about children's access to obscene or harmful content over the Internet
 - Must certify having an Internet safety policy that includes technology protection measures
 - Must block or filter Internet access to pictures that are: (a) obscene; (b) child pornography; or (c) harmful to minors (for computers that are accessed by minors).

CIPA implementation in SBISD

- SBISD must adhere to CIPA by law
 - SBISD exceeds the requirements
- Multiple filtering tools
- In addition to Board policy, SBISD does the following:
- Acceptable Use Policy Acknowledgement
 - Mandatory, annual staff member professional development
 - Mandatory annual parent acknowledgement during the registration\verification process
 - Annual student Digital Citizenship internet safety lessons
- Additional campus specific information provided to parents (parent night, back to school events)

CIPA implementation in SBISD

- SBISD uses multiple techniques. On average:
 - Blocks 30,284 websites per week
 - Blocks over 38,449 malicious website requests
- Over 66 million malicious/phishing/spam url's blocked
- Continually refining and improving the process
- No solution is 100%

- Technology Services may choose to "take action" prior to a committee meeting
- Final approval made by the Filtering Committee
- Decisions made by consensus

Texas Executive Order

TikTok has been blocked at SBISD on district resources for years.

Executive Order issued December 2022 for personal devices

Actions Taken:

- 1. Included in March 2023 Safety Message
- 2. March 2023 SuperNote
- 3. Revised mandated annual cybersecurity training

Cybersecurity SY24



Required annual system administrator training (CQB-Exhibit new SY23)

Overall increasing our overall cybersecurity posture by requiring:

- Staff members accessing tier 1 and tier 2 systems to use MFA (Multifactor Authentication)
- Student network passwords more complex
- Parent Skyward passwords more complex
