  acknowledges all recommendations are based on each professional's understanding of goals, schedule, budget and information available at the time.

## Meeting Objectives

- 2. Review Options and Locations for Graphics
- 3. Present Interior Material Palettes

The following comments were captured during PAT discussions regarding the existing learning environment at Cedar Brook Elementary and potential ways to positively affect the learning environment.

## **Graphics Direction**

1) Entry

- a. Above Reception Counter
  - i. Utilize newer Bulldog Logo as found on the Cedar Brook website
  - ii. Background should be more neutral with pops of Cedar Brook yellow. The yellow Color Code was provided to Huckabee by SBISD
- b. Side Wall
  - i. PAT would prefer the School Name or School Motto to be highlighted. The school name should be larger than the mascot name.
  - ii. More color can be incorporated at this location.
  - iii. Reduce the size of the mascot and/or explore options where paw prints are used in lieu of the mascot
  - iv. Incorporate the dual language and multi-cultural theme at this location.
- 2) Collaboration Neighborhood:
  - a. Core Value Words were selected over Cultural Landmarks by a vote of 5 to 2.
  - b. The simple word without the icon was preferred by the PAT
  - c. PAT would like Huckabee to explore graphics the show the Core Value Words in multiple languages.

## Interior Material Palettes

- 1) Floor Pattern
  - a. The PAT preferred the Pixel Concept over the Linear Concept by a vote of 6 to 2.
  - b. The PAT requested that floor markers within the floor pattern be preserved as these are used to help students line up.
- 2) Color Palette
  - a. The PAT preferred the Color Palette with the Linear Carpet Texture over the Color Palette with the Pixel Carpet Texture by a vote of 5 to 3.



b. Because the selected color palette contains a more saturated accent color, the PAT requested a reduction the amount used in the floor Pattern. Huckabee to revise the Pixel Floor Pattern based on this recommendation.




